5:50	ED report	Nancy Baker has joined OZ. MOTION: Nat motions to approve Nancy's membership. Board approves. Judy R. abstains.

5	6:15	Other HHD debrief	Once the Board votes on a new member, Sarah emails Richard, who does personal outreach. Richard asks the new member how s/he would like to be involved, and sends her/him information about what's going on at OZ. Judy R. believes the Board should have direct contact with a new member before voting to approve membership. Mindy believes such a meeting would be intimidating. <b>Staffing</b> Tari's last day was September 24. Sarah signed a contract with Westaff today to hire a person to work 20 hours per week, for a total term of 300 hours. Karen remains on medical leave probably through the end of the year. Sarah is working to make sure the Shuk is staffed as needed. OZ's building is not currently open for members or volunteers to gather. <b>Dues</b> There hasn't been much change in the last month. A few new pledges have been made this week. Kesef sent bills today to about 80 people who have yet to pledge dues. Current membership is 203 families, much lower than in the past. Last year we had 284 pledges. Hope to have structured conversations with families who still do not respond to Kesef's mailings. Board members will be asked to call families that have not pledged yet, and to keep calling until a person is speaking on the phone. Messaging for these calls will be delicate. We need to emphasize any pledge is acceptable to maintain membership. Should we create a special deal for Hebrew School families and preschool families, many of whom have not become members? <b>High Holiday Donations</b> The total was \$36K, higher than anticipated. <b>Security</b> Sarah is completing a lot of federal paperwork to spend \$1,800 of unallocated funds on window proofing, since it needs to be approved by HHS. Have applied for extension since all funds need to be spent by Oct. 31 but the key card system is still being installed. Should be no problem to get extension. No further discussion about High Holidays.

But the original by-laws, which are more than 40 years old, set it up so that OZ's Board of Directors must amend them. What should be the relationship between OZ's Board and the Synagogue Corporation? Deb and Suzy have examined this issue.
			<b>Deb.</b> : Wants Board to approve two changes, sent in advance.
			<b>MOTION</b> : Delete section 5e of Articles of Association of the Synagogue Corporation ( <i>see below</i> ).

			<b>MOTION</b> : Amend Article VII of by-laws of Synagogue Corporation to include new language ( <i>see below</i> ).
			Mindy motions to close debate. Bill seconds. Board approves.

8	6:30	Treasurer's report	<b>Bill</b> : Until we have a budget, it's hard to compare numbers. But we're doing well at this time because of dues pledges. We have \$300K in the bank, due in some part to large donations. We will move this amount to restricted funds to be able to pull out for specific needs. Budget that was not passed would call for using \$15K to add to operating budget. But this has not been adopted yet.
			How is budget affected by the Westaff contract? We will pay a 50% surcharge to Westaff. Will begin marketing the position at \$18/hour. We have a limited term of 300 hours (about 25 hours per week for 3 months), which totals about \$8K. This fits well within the "budget". Afterwards, we could hire the person who assumes the job and pay less than Westaff's rate because of no surcharge, or we can decide to terminate the relationship.

			What excites members of the Board? Are there at least two items on the list that Board members are excited to move forward with?
			What will be the process to engage members? A small working group should focus on this issue and try to understand current membership and how to reach prospective new members.
			How will COVID affect the synagogue's future operations? What will OZ look like post-COVID? We might need to continue virtual connections even after we return to live gatherings in shul. Our current reality is in such flux that we need to be careful about what we decide to do. One example: Members have been bringing relatives and friends from around the world to connect to Zoom services. Can we monetize these connections, asking these far-flung individuals to donate to OZ?
			We should have a committee that checks in with members at all stages of their membership journey. We need more than a "welcome wagon." We also need a committee to engage members.
			Rabbi Miriam Terlinchamp of Cincinnati, OH convinced her congregation to sell their building because it was too expensive to maintain and didn't serve their purposes. Where is our imagination going to take us?
			<b>ACTION</b> : Could check in with visioning part of ad hoc committee to see where they are going with their discussion. But Nat would like someone else to do so. Josh will reach out to the committee.
			Perhaps we could invite members of the ad hoc committee to discuss their visioning ideas at the November Board meeting, if time allows (or the December Board meeting as an alternative).

### The Synagogue Corporation (Fern Hill Board)

#### Notes from Discussion at December 2019 Congregational Meeting

What ideas do you for how OZ might attract Jewish individuals in our area who are not currently involved here?

- Make services more accessible to families. Saturday morning is tough for kids.
- Test lower-cost membership for two years; make more like monthly gym memberships.
- Rabbi and cantor getting out into community and reaching out to unaffiliated Jews.
- The Hebrew School, preschool, and shuk are huge assets in reaching out to the community. How can we use them more? Do more preschool family outreach -- path to membership.
- Important to clarify where we stand on human rights in Israel.
- Do more JCC/non-religious things/mahjong?
- Consider fee-for-service activities, people willing to pay for specific things.
- Reconsider word "Conservative" -- it is not clearly understood.
- Replace sanctuary chairs w movable pews.
- Reduce membership cost.
- Examine religious vs. "cultural community" focus.
- Mentoring program, with free membership for a year?
- Publicize adult B'nai Mitzvot and promote these more as an option that engages and inspires people.
- Communicate our social justice mission and activities even more.
- Look for opportunities to work across congregations, aiming for affiliation. Could there be an LGTQ congregation that crosses groups.
